

#### **Request for Qualification Statements (RFQS)** Highlights

#### **Estimated Value Ranges for Work Orders**

- Range A Up to approximately \$2,500,000 (SBE set-aside) \*
- Range B approximately \$2,500,000 to \$25,000,000
- Range C Greater than \$25,000,000
- \*Only firms certified as Small Business Enterprise ("SBE") by the Port Authority of New York and New Jersey can qualify for Range A.
- Local business enterprises that are within Tier 1 zip codes as identified in the RFQS are encouraged to submit for Range A if they are eligible to become SBE certified.

All Work Orders have a M/WBE subcontractor goals are 30% (20% MBE/10% WBE)



#### **Request for Qualification Statements (RFQS)**

- Responses due 2:00 pm on August 7, 2020
- **Procurement Contract Specialist** Megan Connors
- The Authority expects to issue **multiple** Master Agreements per range to qualified firms in each range based on the Evaluation Criteria set forth in the RFQS.
- Submittals should be tailored to the specific requirements of the RFQS.
- Submittals shall be evaluated by an Evaluation Committee, which will determine which firm(s) may proceed with award of a Master Agreement.
- The anticipated duration for each Master Agreement is five (5) years, with two (2), one (1) year extension options.



## **Work Order Request for Bids**

After Master Agreements are executed – Work Order Request for Bids shall be used to obtain bids.

Work Orders shall be bid under each designated range based on the amount of the Engineer's Estimate.

Work Orders are typically awarded to the lowest priced technically qualified **responsive** and **responsible** bidder, unless otherwise specified in the Work Order request for bid.

Responsive - review includes but is not limited to areas identified in each Work Order such as -

• Prerequisites, Forms and Submission of Bids, Papers Accompanying Bids, Qualification Information

Responsible - review includes but is not limited to areas such as -

• Past performance, Vendor integrity. Financial responsibility

• 20% MBE and 10% WBE of the total contract award amount

• 20% MBE and 10% WBE of the total amount awarded for each work order



# Achieving the MWBE Goal Two Approaches

1. Indicate which MWBEs you will engage to do what

2. Complete and notarize a participation plan for each MWBE that will be engaged



### Why MWBE Plan is due with Proposal

- 1. It demonstrates intent to engage MWBEs
- 2. It is consistent with the good faith effort guidelines
- 3. It demonstrates you are responsible and responsive to the MWBE requirements



### What happens if no MWBE Plan is Submitted with the Proposal

- We will consider it an oversight and give you 7 days to submit it
- 2. Otherwise, we will require evidence of the good faith effort you made

## **Certification Programs**

Minority Business Enterprise (MBE) Valid for 5 years Women-owned Business Enterprise (WBE) Valid for 5 years

Small Business Enterprise (SBE) Valid for 3 years

Disadvantaged Business Enterprise (DBE) Valid for a year Airport Concessionaires Disadvantaged Business Enterprise (ACDBE) Valid for a year

Service Disabled Veteran Owned Business (SDVOB) Valid for 3 years



## **Eligibility Criteria for Certification**

#### **MWBE**

- 51% Owned and managed by Minority or Women Owner(s) who are citizen or permanent residents.
- Make critical day to day decisions.
- capital contribution are real and substantial
- Been in business for a year.

#### DBE/ACDBE

 DBE is 51% owned by individual or individuals categorized as economically or socially disadvantaged citizens or permanent residents as per CFR 49 part 26, has size standards for program and industry, NAICS codes, Site visits required and we have UCP Partnership with New York and NJ


 ACDBE is DBE designed for Airport Concessionaires and has a higher threshold.

#### SBE/SDVOB

- SBE is race and gender neutral. Needs firm based in NY&NJ, year(s) in business and meets SBA threshold standard for industry.
- For Construction firms needs qualification by Engineering Dept.
- SDVOB is 51% owned and managed by Service Disabled Veteran Owner(s)
- Letter or documentation issued by Veteran Affairs showing SDVOB status.
- Principal place of business in NY&NJ



## Focus of the Certification Review Process





#### **Documentation that support Certification**

Signed and Notarized Verification and Validation form

- Valid U.S. Passport, Valid Resident Alien Card and/or Birth Certificate
- Taxes for last 3 years Articles of Incorporation and Stock Certificates By-Laws or Operating Agreement
- Executed Contracts Resume (s)
- Bank Signature Cards Lease Agreements
- Specialty License or documentation related to business
- Certification of Business (If Applicable)
